Rapid Re-Housing (RRH18) is a comprehensive Permanent Housing-Rapid Re-Housing program using the latest in research and mandates from The United States Department of Housing & Urban Development (HUD). RRH18 utilizes outcome and performance measures to ensure client success and self-sufficiency. RRH18 will serve the most vulnerable populations include: the chronically homeless, veterans and their families, and those fleeing domestic violence. RRH18 will utilize a Service Point Vulnerability Index (VI-SPdat) to determine the greatest need of PH. RRH18 will also utilize the Coordinated Access program to ensure that outreach and waiting lists are identified and clients are served first. RRH18 is a low barrier program with the goal of shortening shelter stay and shorten time in places not meant for human habitation. RRH18 is modeled after the HUD mandate "Opening Doors." Twin City Mission (TCM) and RRH18 is currently working towards the goal of ending homelessness by 2020 in the Brazos Valley region of Texas. The Housing First approach is new and innovative in the Brazos Valley and stands as a model to other homeless programs with a data-driven approach to ending homelessness. RRH18 will provide 100% of homeless participants rent for six months. With optional case management, it is imperative that participants access all mainstream benefits available and be referred to budget management to ensure self-sufficiency in the future.
